DIRECTIONS FOR USE:

Administer as a single dose by mouth. **Dose**: Weigh dog to determine dosage, giving one (1) tablet per 10kg bodyweight, rounding up to the nearest ¼ tablet. Treatment is best given after a meal in the morning.
